## Vendor Requirements

- **All** vendors are required to pay for trash and electric.
- **All** tents must meet KY tent regulation standards that include a KTS registration number along with the anchoring and reaction diagram.
  - If this cannot be provided, you will be **required** to rent through our provider for an additional charge.
- **All** vendors are required to meet the guidelines set forth by the Lexington Fire Department and Lexington-Fayette Health Department. If you do not comply with their guidelines, you risk being shut down and losing your deposit.
- **All** staff are required to follow our vendor entrance guidelines issued by the Lexington Lions Club Bluegrass Fair staff OR pay daily admission into the Fair grounds.
- 4 Vendor Passes are included per location per day. Vendors must use side and back vendor entrances. Vendor Passes will not be accepted through main entrance gates. There is no guarantee additional vendor passes will be made available.
- NO Staff will be admitted without a valid Vendor Pass or paid general admission entrance.

*Additional requirements will be included in the vendor contract upon approval.*
